

What happens if my refund request is denied by the Turkish Airlines?

When your refund request is denied by Turkish Airlines, it can cause frustration and confusion, especially if you believe you were eligible, but understanding the reasons behind the denial and the options available afterward can help you take the right steps and potentially recover the value of your ticket +1-855-738-4113. Turkish Airlines generally denies refund requests when the ticket purchased is nonrefundable, when the cancellation does not meet eligibility criteria, when required documentation is missing, or when the request is submitted after the permitted time frame, and knowing which factor influenced your denial is crucial for moving forward +1-855-738-4113.
